



WHAT ARE 'HALAL ORGANS'?



Despite there being no such thing as '**Halal Organs**' in Islamic ruling or practice, this refers to the organs of people who haven't been exposed to Islamically forbidden acts such as consuming alcohol, pork amongst other things considered 'haram' in the Islamic culture.



WHAT IS HAPPENING

In 2016, Uyghurs had to undergo mandatory DNA testing and in some cases ultrasounds. The reasoning was unclear.

UYGHURS SLAUGHTERED ON DEMAND



A Chinese woman, Ms. Aili described how she had personally witnessed China's **live organ harvesting program** in practice in 2006 at the Department of Liver Transplantation, Tianjin Taida Hospital in the city of Tianjin, China.

She was a witness of 37 Saudi nationals who received '**Halal Organ**' transplants from '**donors**' located in **East Turkistan**. The reason she said they want people from that region is because Saudi's have created a demand for 'Halal Organs'

DR. ENVER TOHTI



"I was called by my chief surgeon to go to a room near the Urumqi execution grounds to remove the liver and two kidneys from an executed prisoner,"
"It turned out he wasn't fully dead because they [Chinese execution squad] shot him through the right chest [intentionally] to knock him out [without killing him], so I would have time to remove his organs."

He recalled that during surgery, the blood flow remained, indicating that the heart was beating and the patient was alive during the surgery.

Tohti states that the demand for Uyghur 'Halal Organs' far outweighs the supply and this is why the Chinese Communist Party implemented mandatory DNA testing with the objective of having a "live organ-matching database"

Organ harvesting operations are performed on **live victims** where their body parts are often sold to wealthy Saudis. The operations are organized and paid for from their home countries. The patients only travel to China once the organ has been matched and all paperwork filled.

In 2014, China claimed that **forced organ harvesting** was outlawed. However, an **independent tribunal** collected eyewitness and expert testimonies which concluded that China continues to perform an excessively high number of transplants to substantiate those claims.

“The conclusion shows that very many people have died indescribably hideous deaths for no reason, that more may suffer in similar ways and that all of us live on a planet where extreme wickedness may be found in the power of those, for the time being, running a country with one of the oldest civilisations known to modern man.”

- *China is known for being a country with the shortest wait time for receiving and transplanting human organs. This is true despite the fact that in Chinese culture, people prefer to keep the body intact and therefore, do not donate organs after death.*
- *Average wait time can be as little as 12 days. Compare this to the U.S. where the wait time averages at 3.6 years.*
- *Some patients are told the exact day of their operation in advance. Meaning, a hospital knows the date of death of future 'donors'*
- *Concentration camp victims are tortured; Prison guards shoot body parts of the victims that lead to a slow death and keep them alive long enough for the needed organ to be removed.*
- *In order to attract more Muslim clients, the Chinese government advertises the organs to be 'Halal' because the 'donors' are Muslim and do not consume pork or alcohol.*
- *Each organ has its own price. A liver can post upwards of \$100 000 and 'Halal Organ' prices are tripled.*
- *At Kashgar airport, there are designated lanes for those transporting organs.*
- *Former detainees of China's concentration camps revealed that they underwent repeated medical check ups and gave regular blood tests.*
